Fishing Permit Application

Dear Westlake Resident and/or Property Owner:

This fishing permit application is required of anyone seeking to obtain fishing permits to fish at Westlake Lake. Each Westlake community resident and property owner and their family and guests who fish, even if from their own property, is required to obtain a permit badge. A fishing pamphlet which outlines our rules for fishing will be sent to you along with your badge(s).

FISHING PERMIT AGREEMENT FOR WESTLAKE LAKE

WLMA issues the below numbered fishing permit(s) to the undersigned individual (collectively male and female "Fisherman"). This permit allows FISHERMAN to fish on Westlake Lake which is in both Los Angeles and Ventura Counties, California from those specific areas designated by WLMA. In consideration of WLMA issuing the permit, FISHERMAN agrees to the following terms and conditions.

1. FISHERMAN is aware that there is a danger in walking upon the banks, shoreline, docks, and piers, and in the utilization of boats. FISHERMAN agrees that WLMA shall not be liable under any circumstances for loss or damage to his or her personal property or personal injury to himself or herself from any cause.
2. FISHERMAN agrees to indemnify and hold harmless WLMA, including cost of WLMA's defense, as incurred; If WLMA is found liable for loss of damage to personal property or injury to any guest, invitee, or relative of FISHERMAN while they are accompanying him or her or during the course and scope of fishing activities under the permit.
3. FISHERMAN agrees to abide by WLMA's rules as detailed in the Fishing Pamphlet and this application as to the use of Westlake Lake with special acknowledgement being made that Westlake Lake is a catch and release lake. No fish may be removed from the lake except for invasive fish species, common carp. WLMA authorizes and encourages persons fishing the Lake to catch, remove and dispose of common carp with disposal under WLMA guidelines (See Rule 2B and Rule 32 in the Lake Rules). All hooks must be barbless or have barbs pinched down. *To prevent injury to the fish, and maintain the lake ecosystem, no live bait of any kind is allowed. This includes cut live bait or other organic material such as goldfish, crawfish, baby bass, bluegill, shiners, waterdogs, earthworms, night crawlers, grubs, or dead "live bait." No food products may be used (i.e., hot dogs). Soft, catfish bait may not be used. Use only artificial lures, plastic baits, spinners, or artificial flies.* When fishing, promptly release fish caught back into the lake, unless common carp. Avoid maneuvering your boat near other boats.
4. FISHERMAN acknowledges he or she must also abide by the laws of the State of California with special emphasis on the State Fish and Wildlife Code which the state has the right to enforce on Westlake Lake.
